

SUMMARY MINUTES OF SEALE AND SANDS PARISH COUNCIL MEETING HELD AT  
SEALE VILLAGE HALL, SEALE ON MONDAY, 15<sup>th</sup> January 2018 at 7.30 pm

PRESENT: - Cllrs. Mr W A Nelson, Mr I Brown, Mr J Butcher, County Cllr. M Furniss, Borough Cllr. T Rooth and the Parish Clerk. There were 3 members of the Public present.

1. WELCOME & APOLOGIES – There were apologies received from Mr & Mrs C Parrott.
2. DECLARATION OF NON & DISCLOSABLE PECUNIARY INTERESTS – There were no declarations made.
3. CONFIRMATION OF MINUTES OF 20<sup>th</sup> November 2017 - Minutes were confirmed and approved as correct.
4. PUBLIC FORUM – Issues raised included: Crooksbury Hill SWT Planning Hearing and Police activity in Seale.
5. COUNTY COUNCIL MATTERS – Cllr. Furniss reported on: Highways, resurfacing of Seale Lane; Transport Network - Public Exhibition in Tongham; Speed Limits; Seale Lodge 'The Bund' – investigating.
6. BOROUGH COUNCIL MATTERS – Cllr. Rooth reported on: Local Plan; Recycling/Waste collections; Land at Wanborough 243 acres sold off (possible development?).
